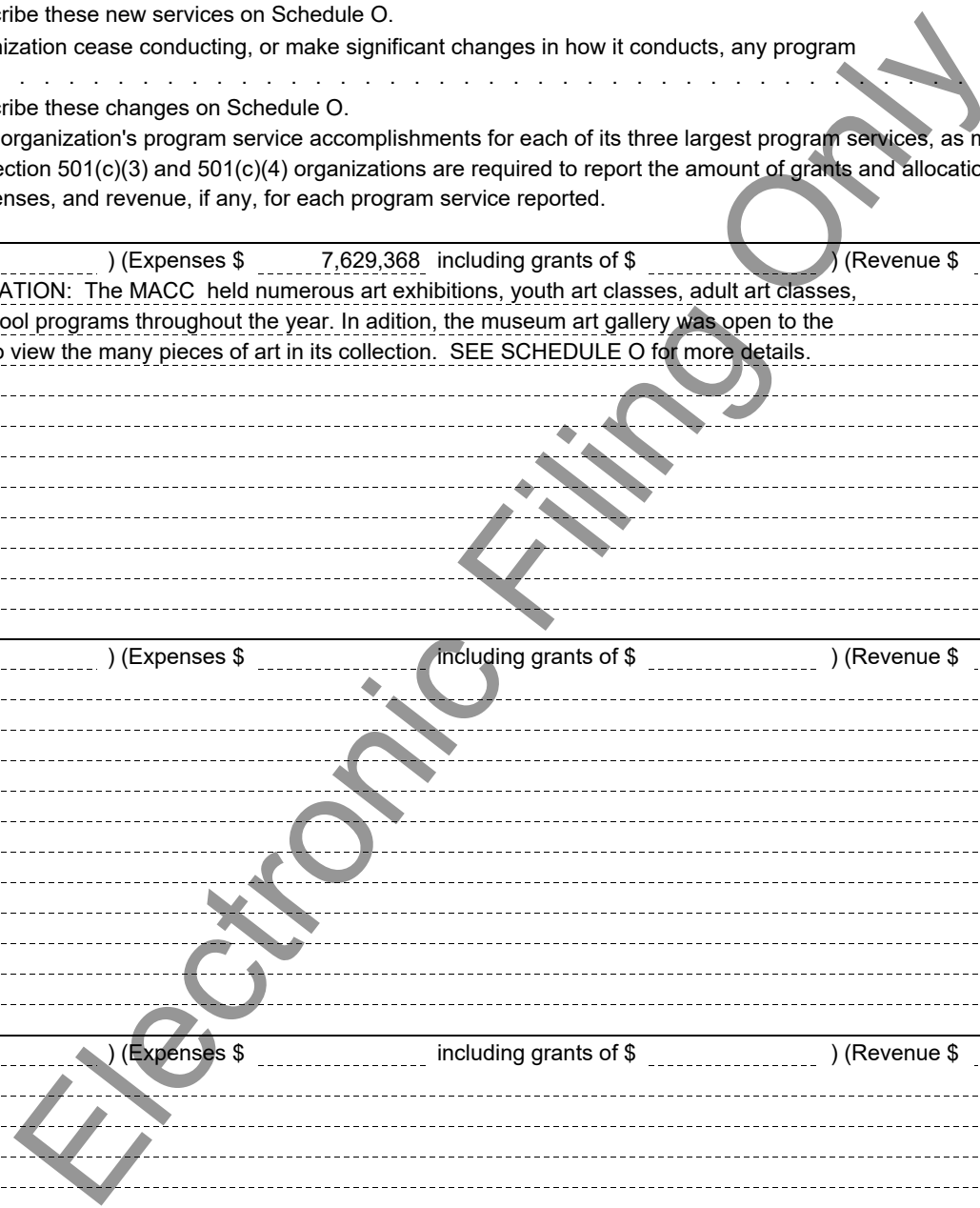

Exhibits include legendary masters such as Picasso, Rembrandt and Salvadore Dali, as well as local artists from Middle Tennessee. We host Black History Month exhibits and annual Student Art Shows. Exhibitions are free to the public. Art education and outreach are central to our mission. Over 1,000 youth and adults are enrolled in art classes each year. We also send teachers out into the community providing free art classes to underrepresented youth and families. Our teachers reached over 5,000 participants in this program last year. In addition, we send healing arts facilitators to work with military veterans suffering from PTSD and TBI at the Charlie Daniels Center at MTSU and at the Veterans Recovery Center in Murfreesboro, at the American Legion Post 45 and the Veterans Residence in Gallatin, and at the VFW Post 9851 in Hendersonville.
